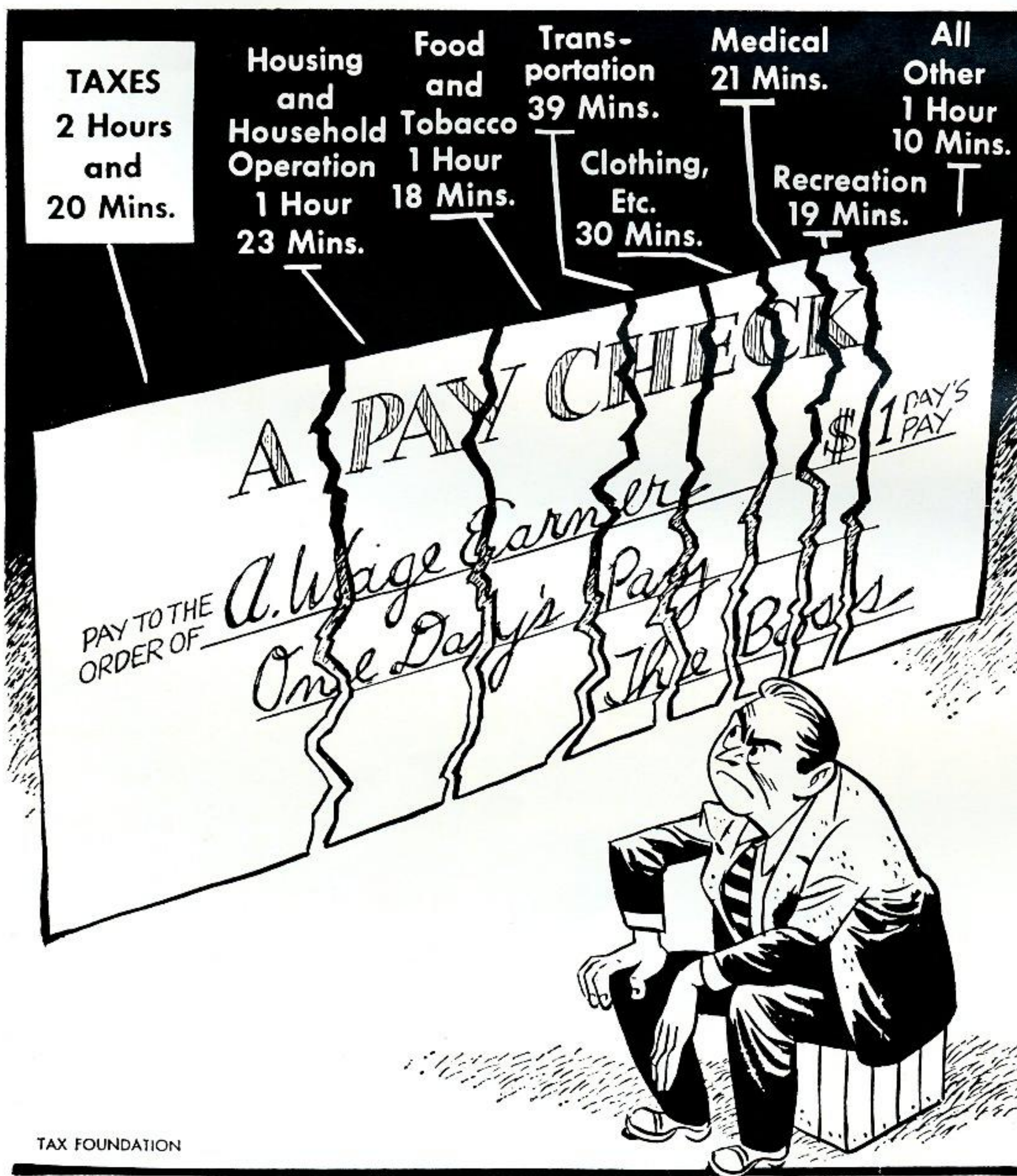

Sabine Station Takes on New Look

As Steel for Number 3 Unit Goes Up

CONSTRUCTION activity proceeds at a steady clip on a flat expanse of land near Bridge City, Texas—the heart of the industry-dotted Golden Triangle.

It's at our Company's three-year-old Sabine Power Station, where more than 200 workers are busy with construction and

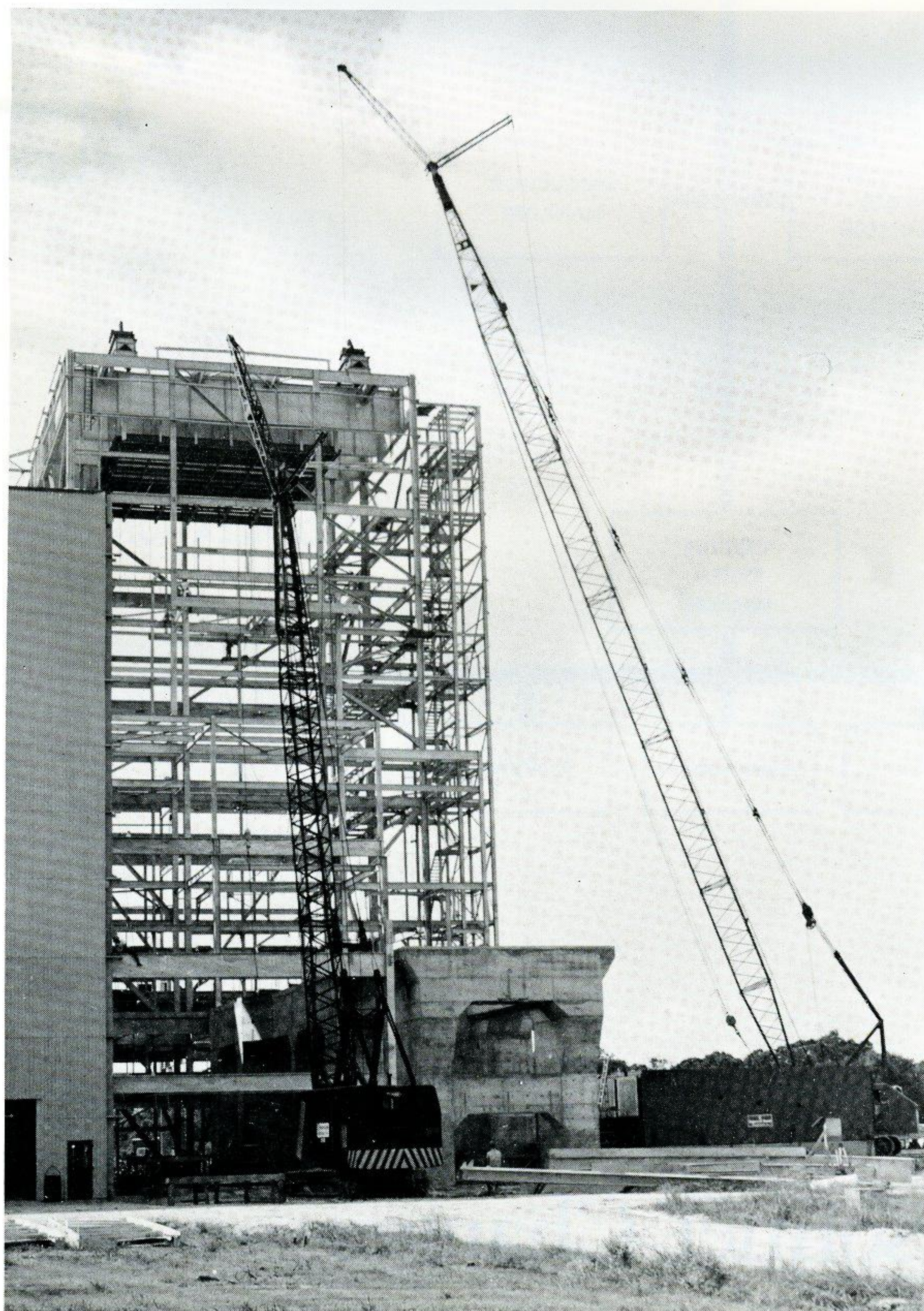
installation of a 440,000-kilowatt turbo-generator that ranks as one of the largest single units in the Southwest. On-site activity began last October with Stone & Webster Engineering Corporation crews setting sights on a November 1, 1966, completion target date.

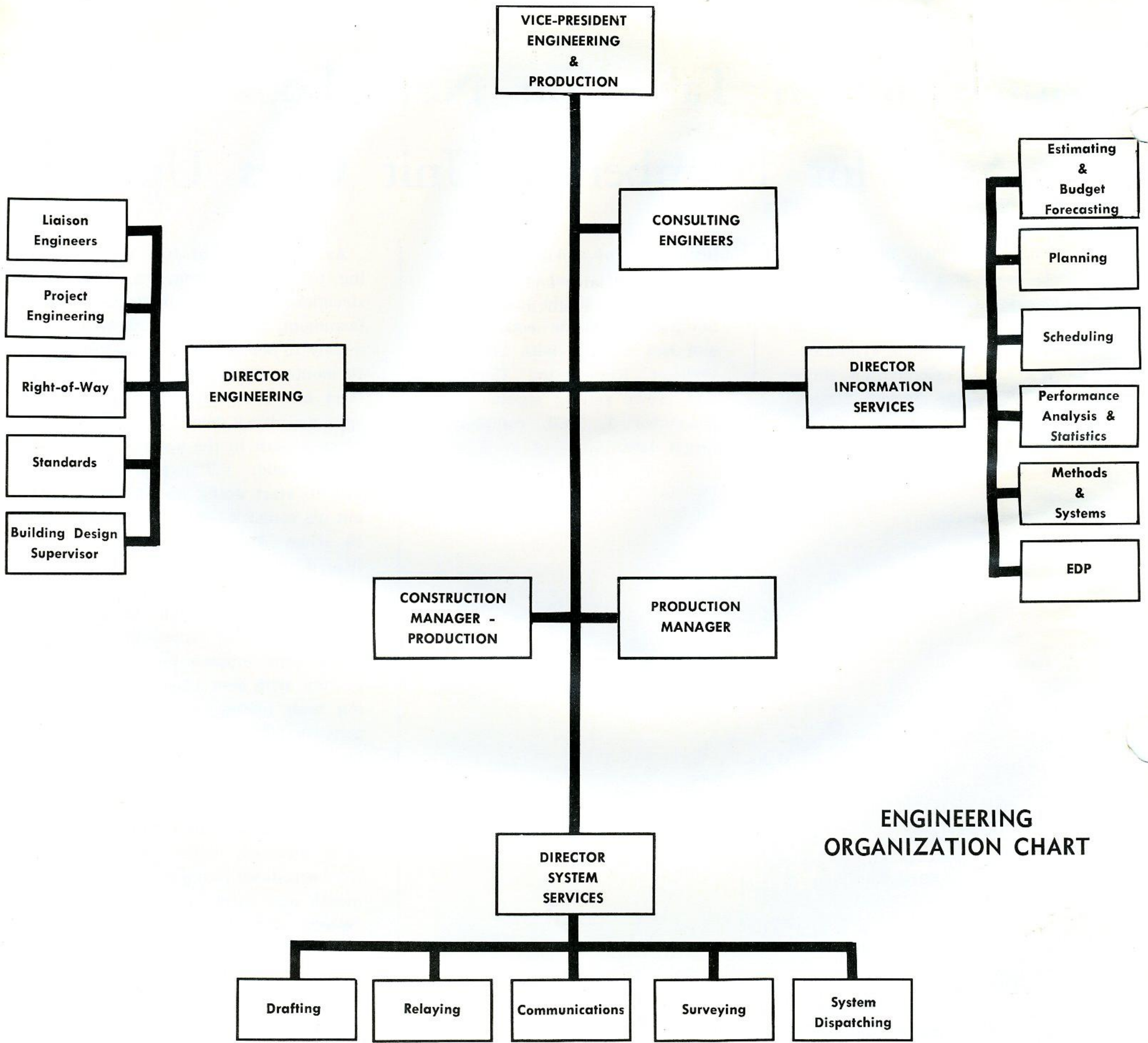
As of the first of July, according to F. A. Wilson, Jr., construction manager-production, Beaumont, the job stood approximately 16 per cent complete after 10 months work. "We expect to meet our 25-month deadline despite a six-week delay on delivery of steel back in the spring," Mr. Wilson said. "Structural steel was to start going up March 1, but we couldn't begin until April 15 when American Bridge delivered the steel."

He said that structural steel erection, which began in the boiler area, was approximately 60 per cent complete by the first of July, with over 1,100 tons having been placed. Steel used in construction was fabricated nearby at American Bridge Division of U.S. Steel Corporation at Orange.

The turbine foundation has been finished, boiler erections were scheduled to begin early this month and work is progressing "nicely" on all fronts, Mr. Wilson reported. He said most underground work is complete with the exception of the intake screen well and discharge outlet, which are underway.

One of the latest innovations in power plant construction effecting considerable savings over the years—first used in part on Sabine Numbers One and Two and fully on steel for Willow Glen Number Two—is being continued on this unit. Every piece of steel used in the project is galvanized and those too large to be dipped are metalized with a zinc coating. All of which is designed to curtail future painting and maintenance costs.

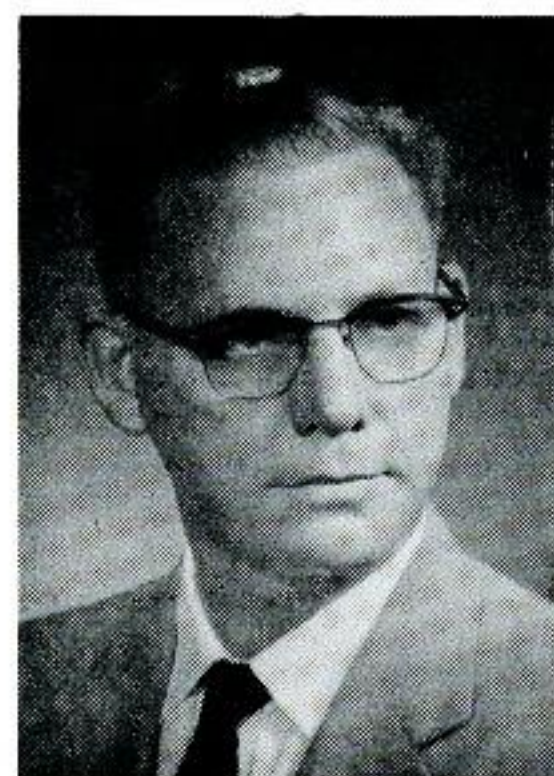

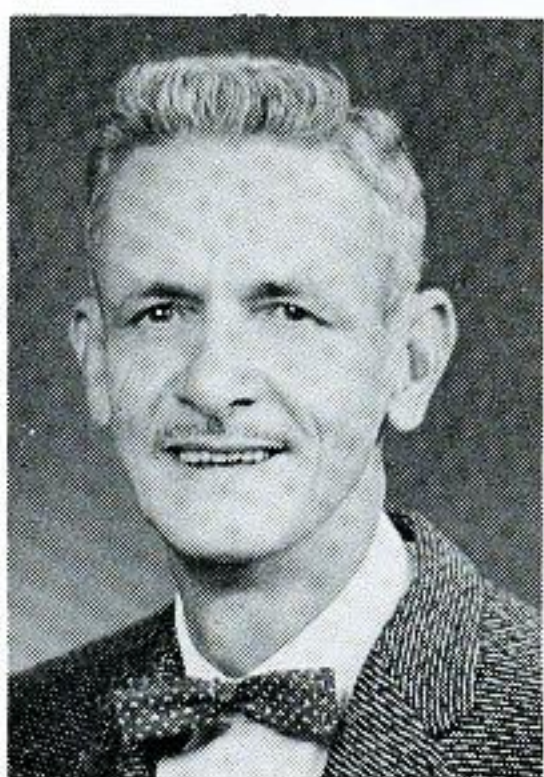

In 1934 he was moved to Beaumont where he became a helper in the Substation Department of

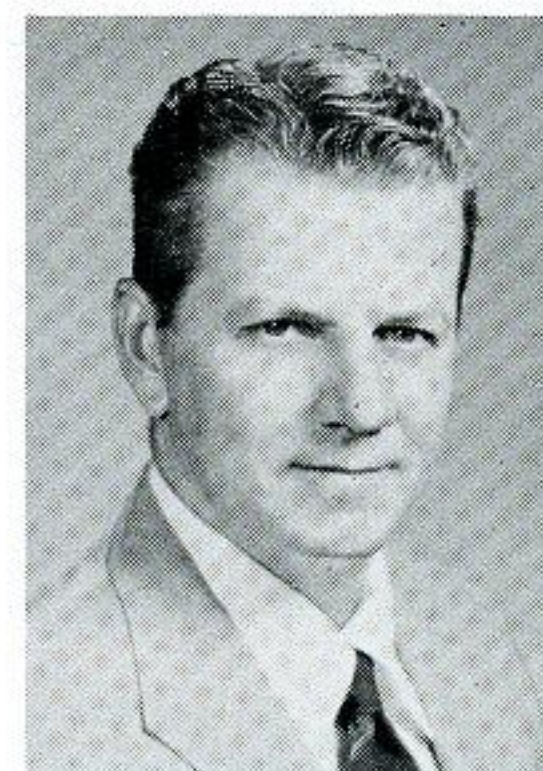

According to Richard J. Anderson, editor and publisher of *Financial World*, winners will be chosen by board of judges and its selections will be announced in September.

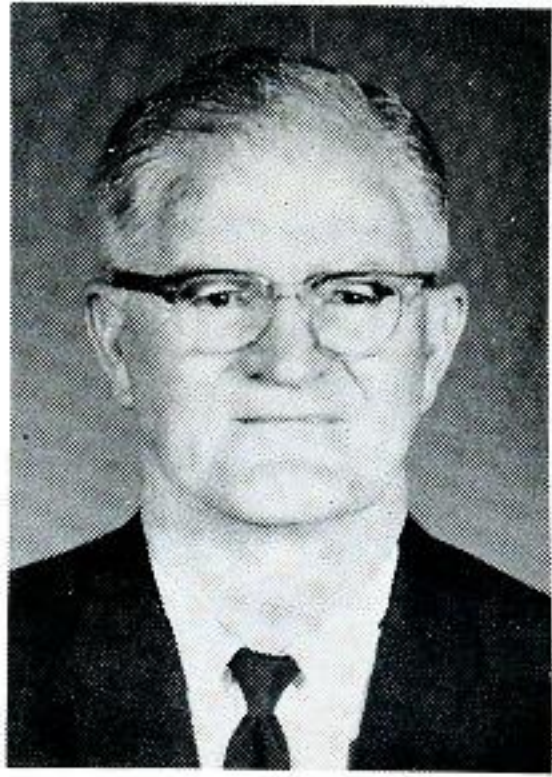

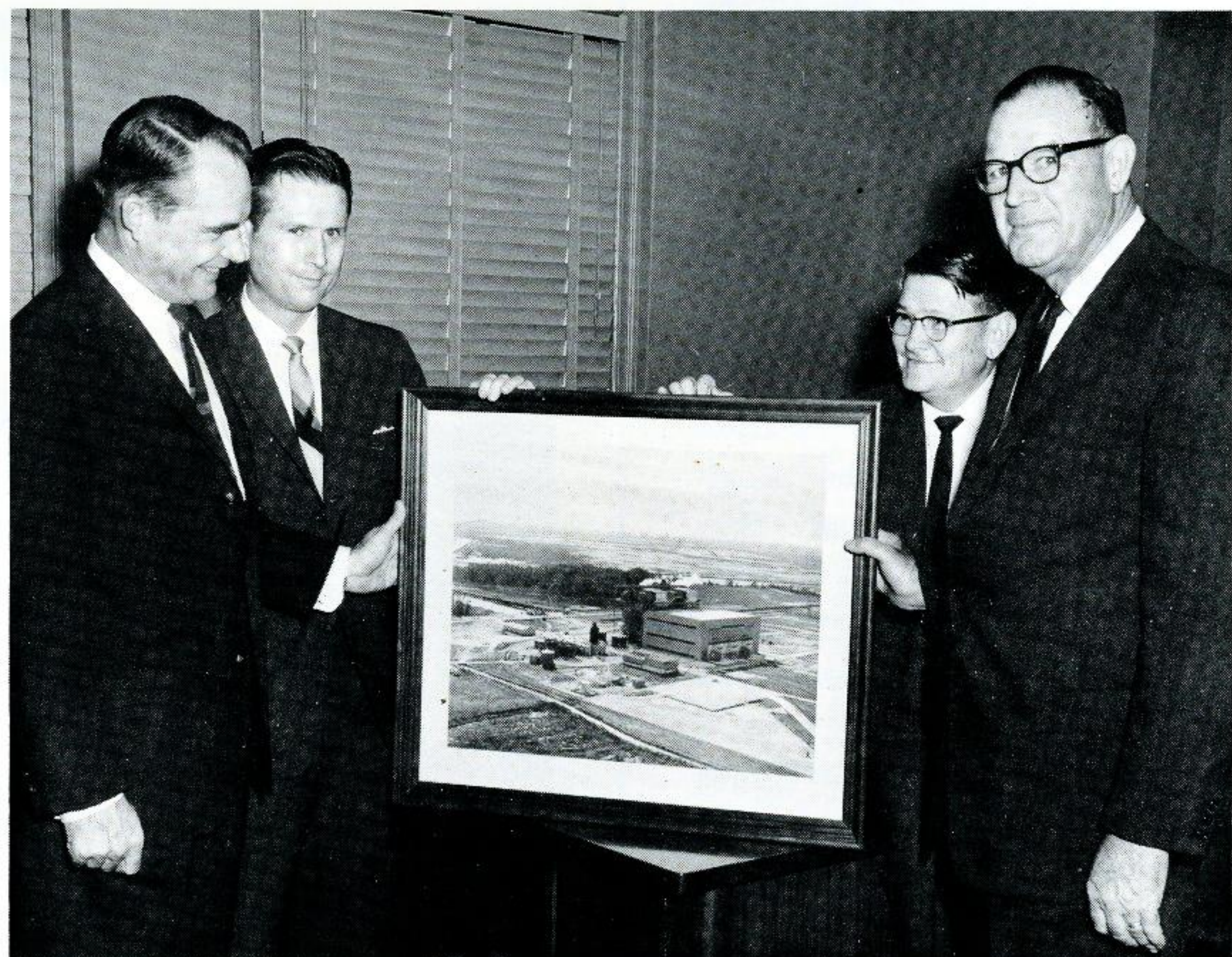

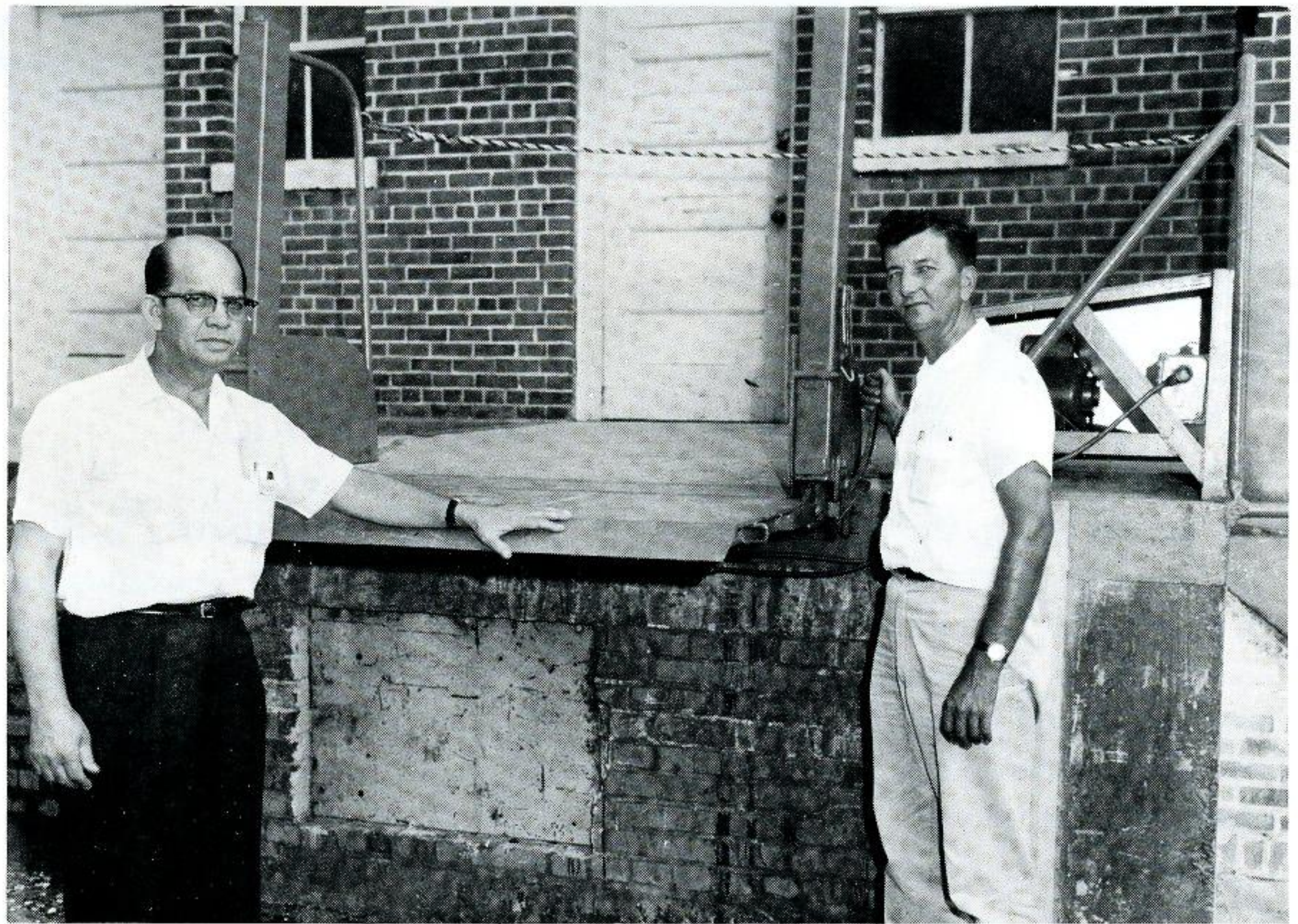
He is married to the former Naomi Kirkland of Liberty, Miss.,

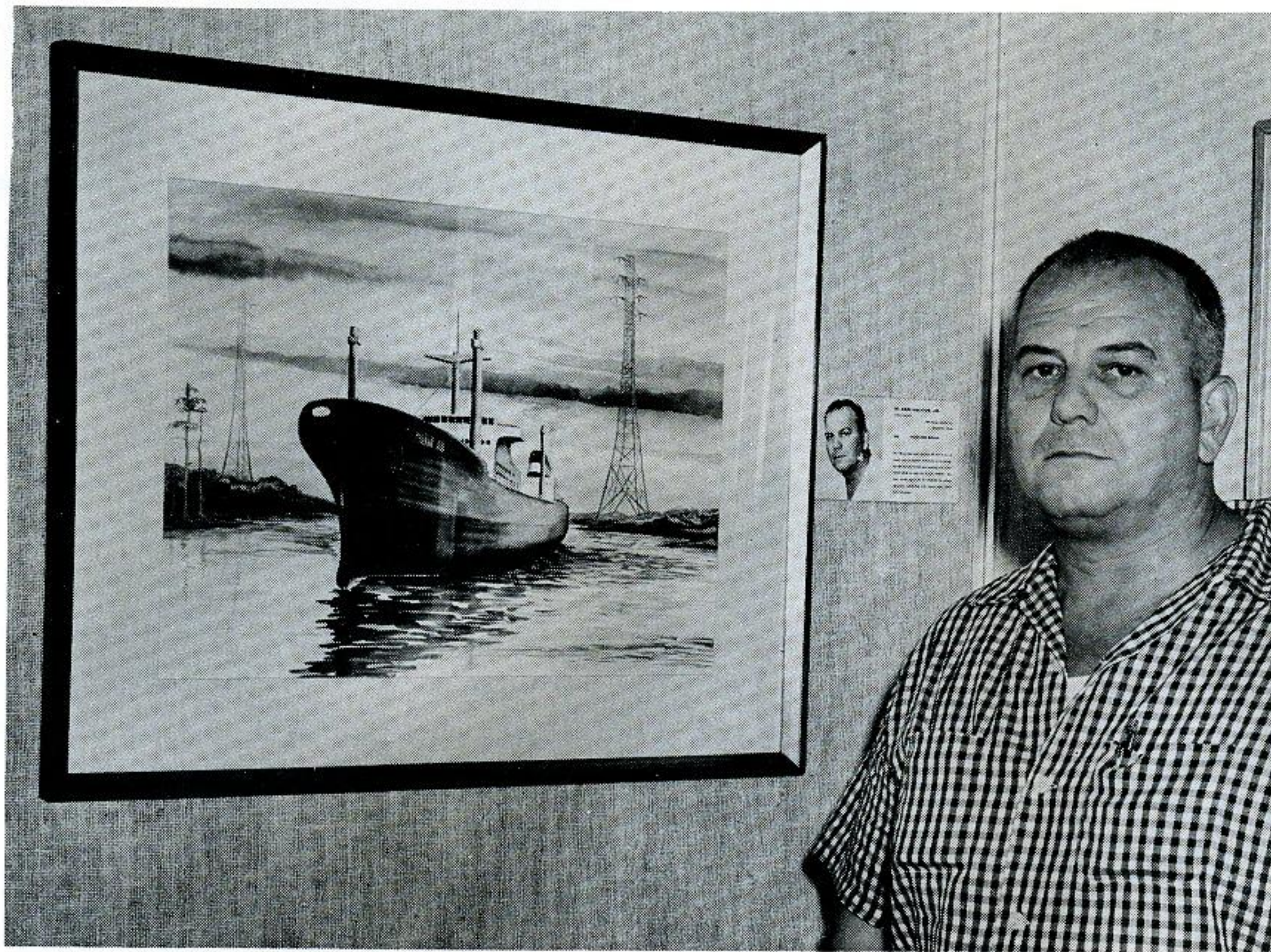

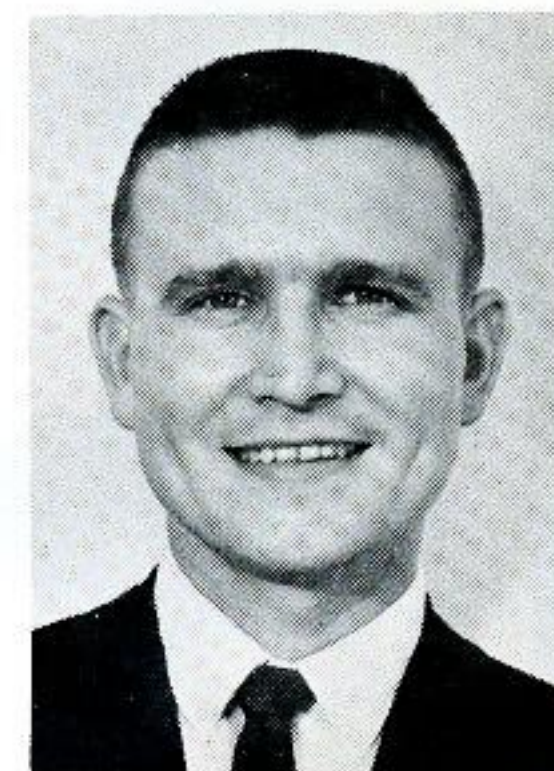

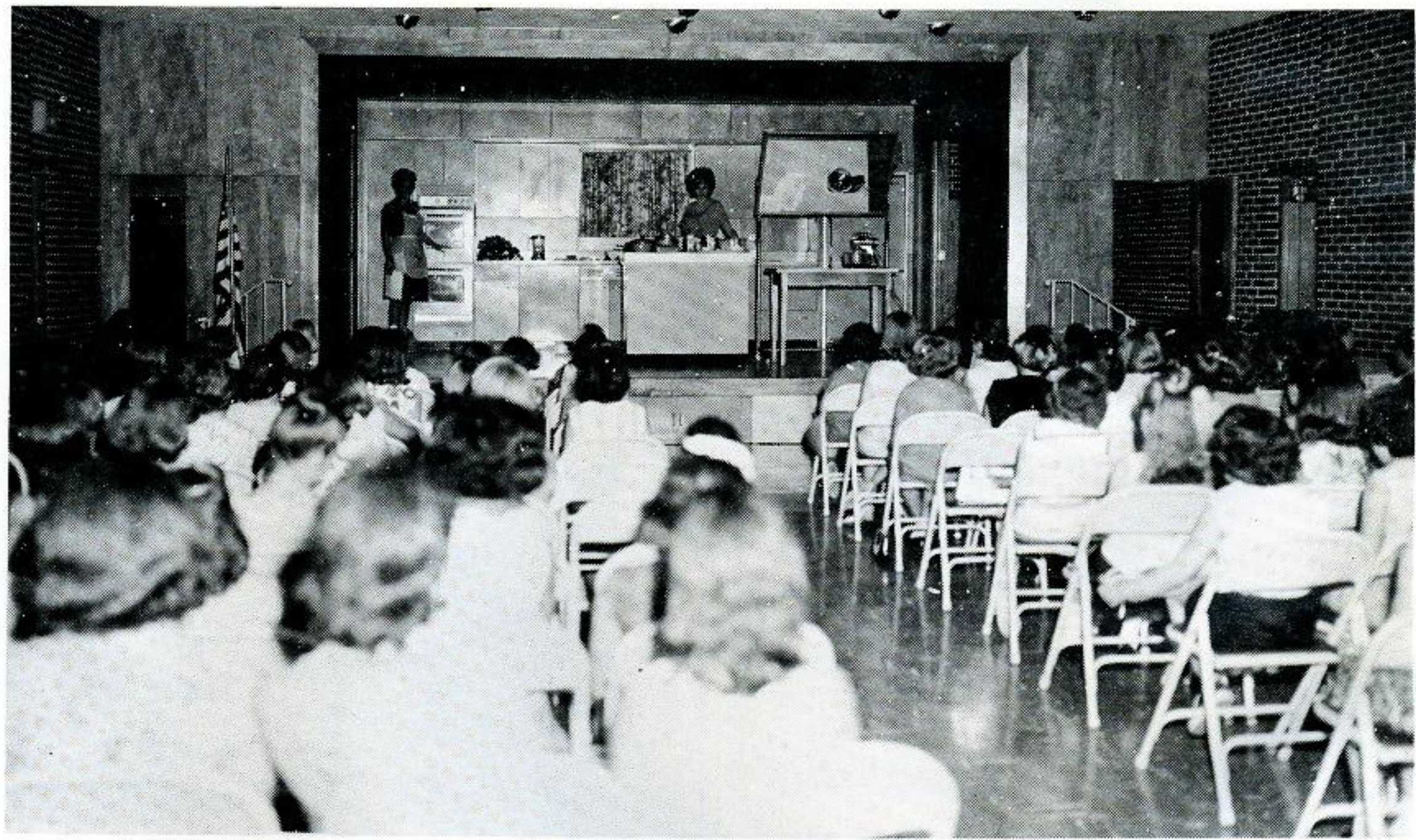

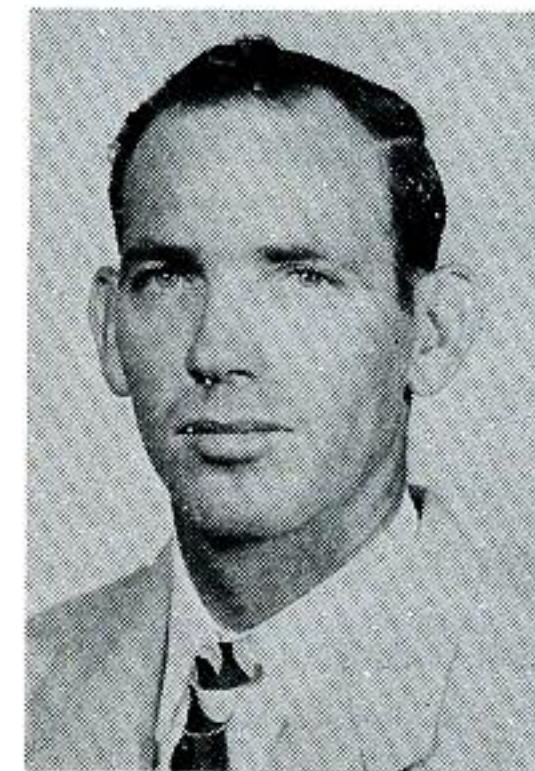

Training to Begin Home Study Course for T&D Personnel

BEGINNING September 1 our Company's Training Department will make available a new home study course for T&D personnel according to Jack Shirey, manager, Training and Safety, Beaumont.

"The course is designed to increase the understanding of T&D employees in electricity, electrical terms and electric systems, actual distribution and transmission line construction and maintenance procedures, and safety rules and regulations.

"This course will be a complete and comprehensive job related course for all T&D people. While ideally suited to personnel in the Line Department, it contains enough basic theory, general information and safety topics to make it valuable to personnel in all departments," Mr. Shirey said.

The course will be a three year program containing three volumes with 18 lessons in each

volume. Each lesson will consist of assigned reading in the text, supplemental reading (furnished by the Training Department), references to distribution standards, references to safe working practices, and questions to be answered and returned to the Training Department.

Enrollment in the course will open around mid-August. A booklet is now being prepared explaining the program and will soon be available in all T&D offices and the Training Department. The first lesson will be mailed September 1.

Text for the course will be "The Lineman's and Cableman's Handbook", 4th Edition, by Edwin B. Kurtz. A copy of the text will be sent to each enrollee.

The supplemental materials that accompanies each lesson will be compiled by company engineers in conjunction with the Training Department.

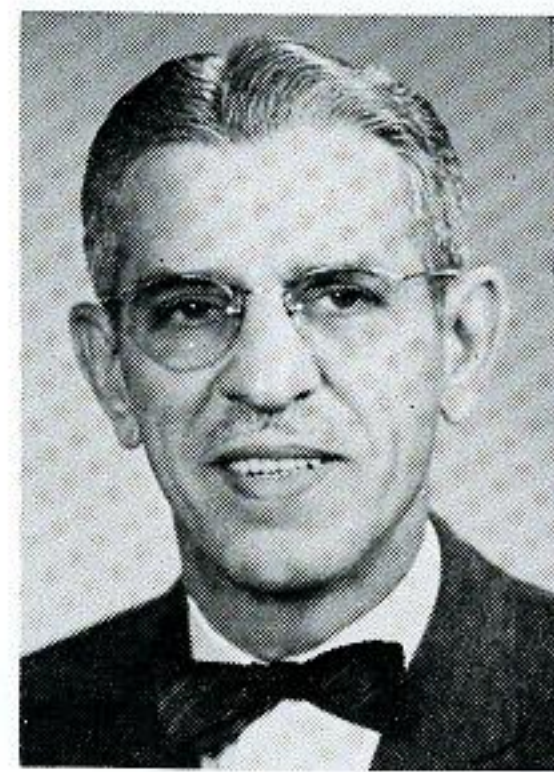

Industry Spent \$152.7 Million

On Research in 1964

RESearch and development expenditures by 148 electric utility companies, by Edison Electric Institute and by 14 manufacturers on research and development activities specifically identified with electric utility equipment totaled \$152.7 million for 1964.

In a just-completed survey, the electric utility companies reported research and development expenditures of \$46.1 million, EEI reported \$1.1 million, and the manufacturers reported \$105.5 million to make a total of \$152.7 million.

The figures represent preliminary results of a study, conducted by EEI's research development, which covers the research being carried out in the equipment and techniques of the electric utility industry.

These totals are conservative measures of the magnitude of research and development being devoted to the electric power industry and the benefits of its customers.

The three atomic research projects in which our Company participates have cost our Company in excess of \$1 million. These projects are the Texas Atomic Energy Research Foundation, Southwest Atomic Energy Associates and High Temperature Reactor Development Corporation.

The TAERF is composed of ten Texas electric utilities working with General Dynamic Corporation on a \$10 million research program in the field of controlled fusion.

SAEA is composed of our Company and 16 other utilities in the Southwest with the objective of

developing an advanced type of fission reactor. Fission of uranium is the source of heat being used in all presently operating nuclear power stations.

HTRDC is composed of 52 utilities from across the nation and has just completed construction of an atomic power station in Pennsylvania with the assistance of the U. S. Atomic Energy Commission. This project is busy with research toward advancing the technology and economics of nuclear power generation. It's hoped that the Pennsylvania plant will provide a shortcut to the goal of economically generating nuclear power.

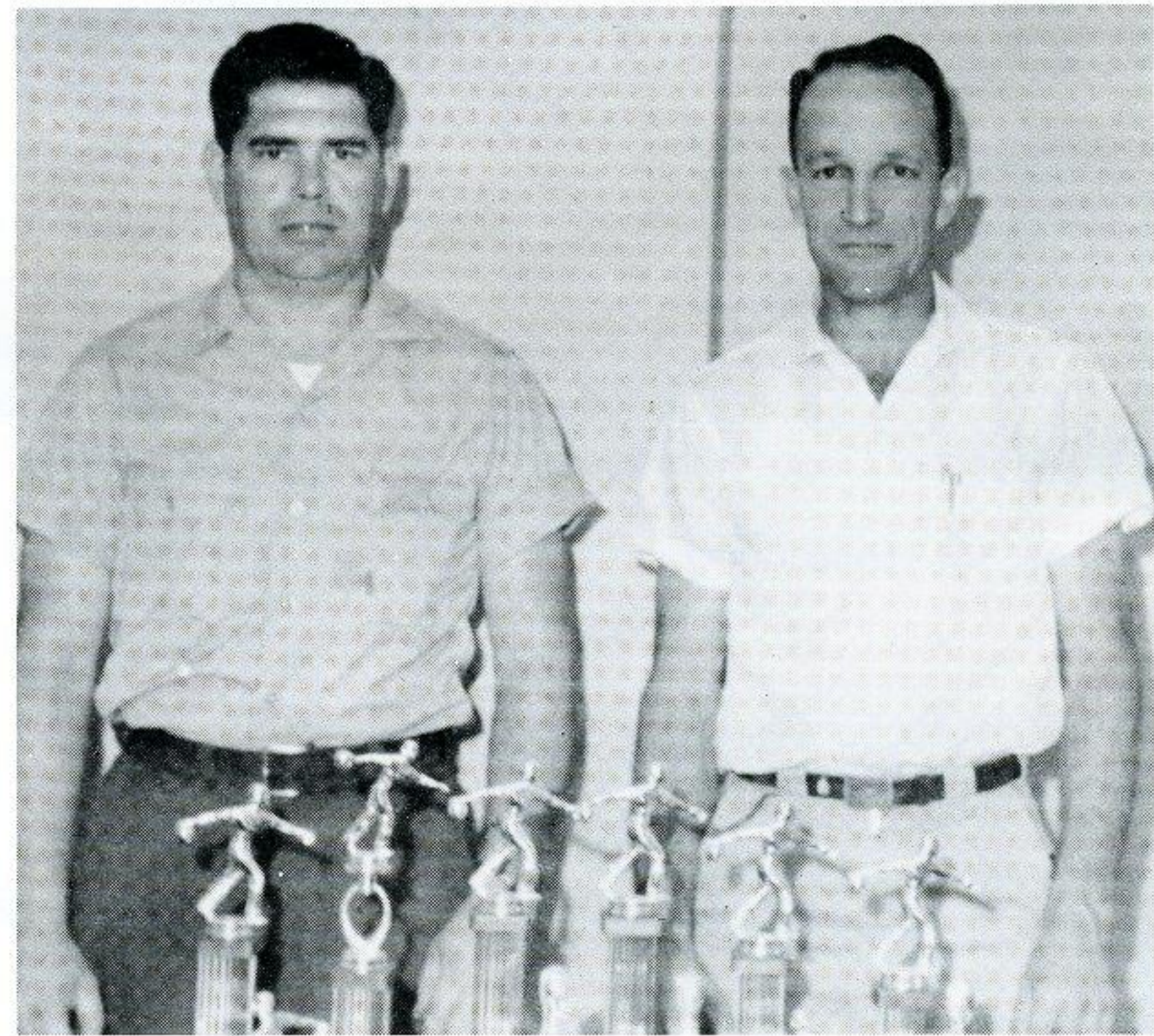

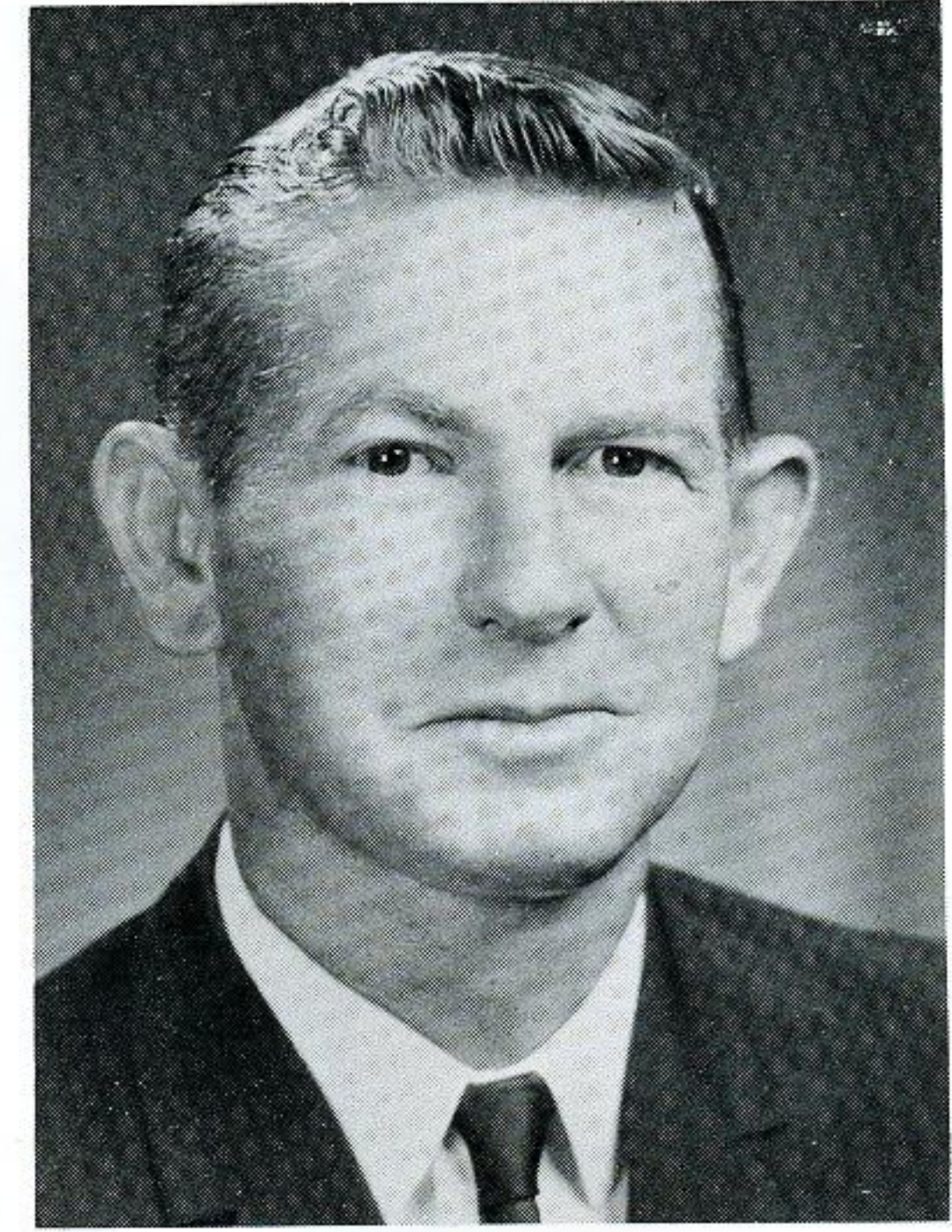
Claude Britnell Dies Following Electrocution

He had been in the Port Arthur Line Department since joining our Company on July 25, 1955.

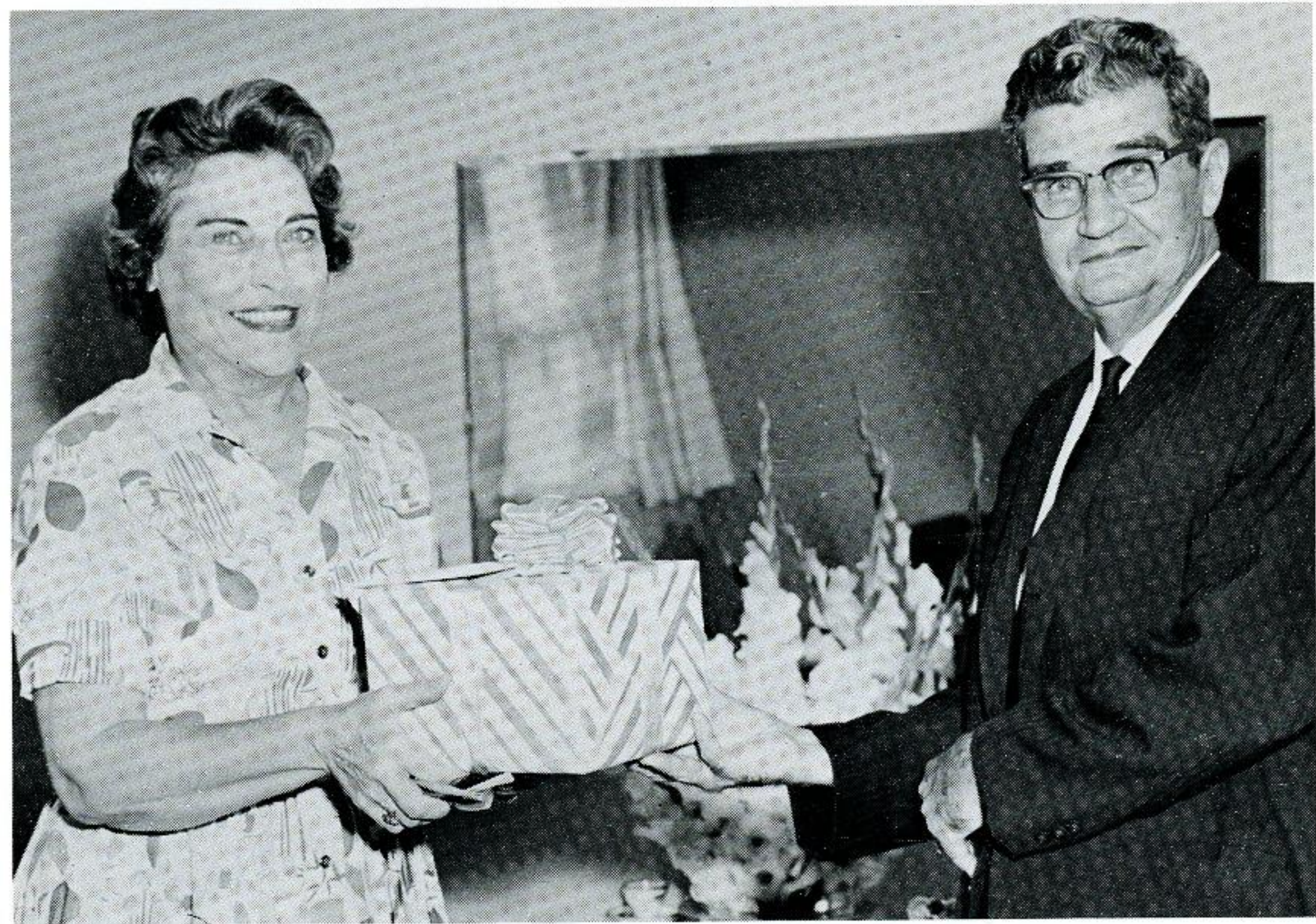
He was a member of Trinity Baptist Church in Port Arthur and was a 1951 graduate of Thomas Jefferson High School. A veteran of the Korean War, he

was also a member of the American Legion.

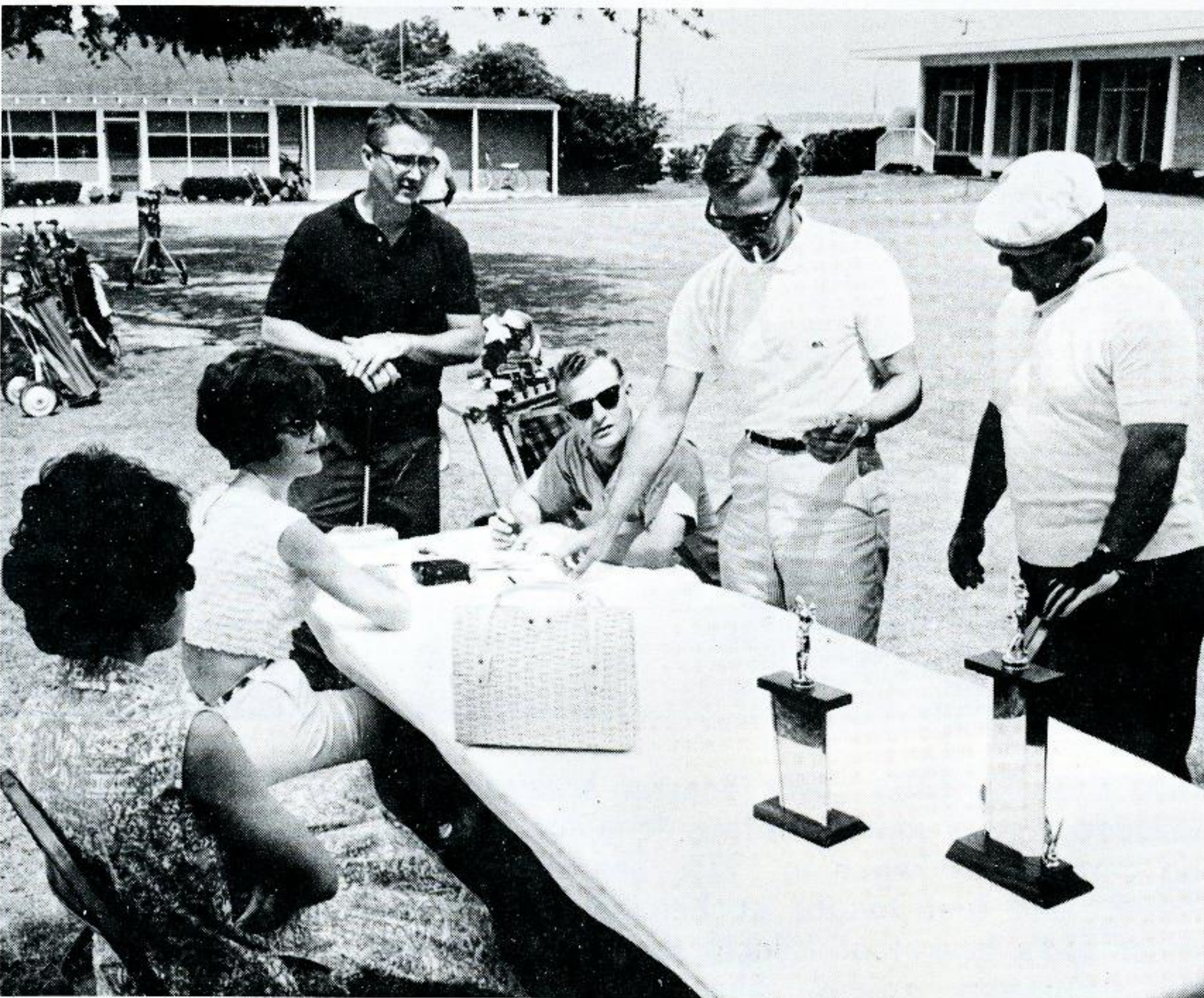

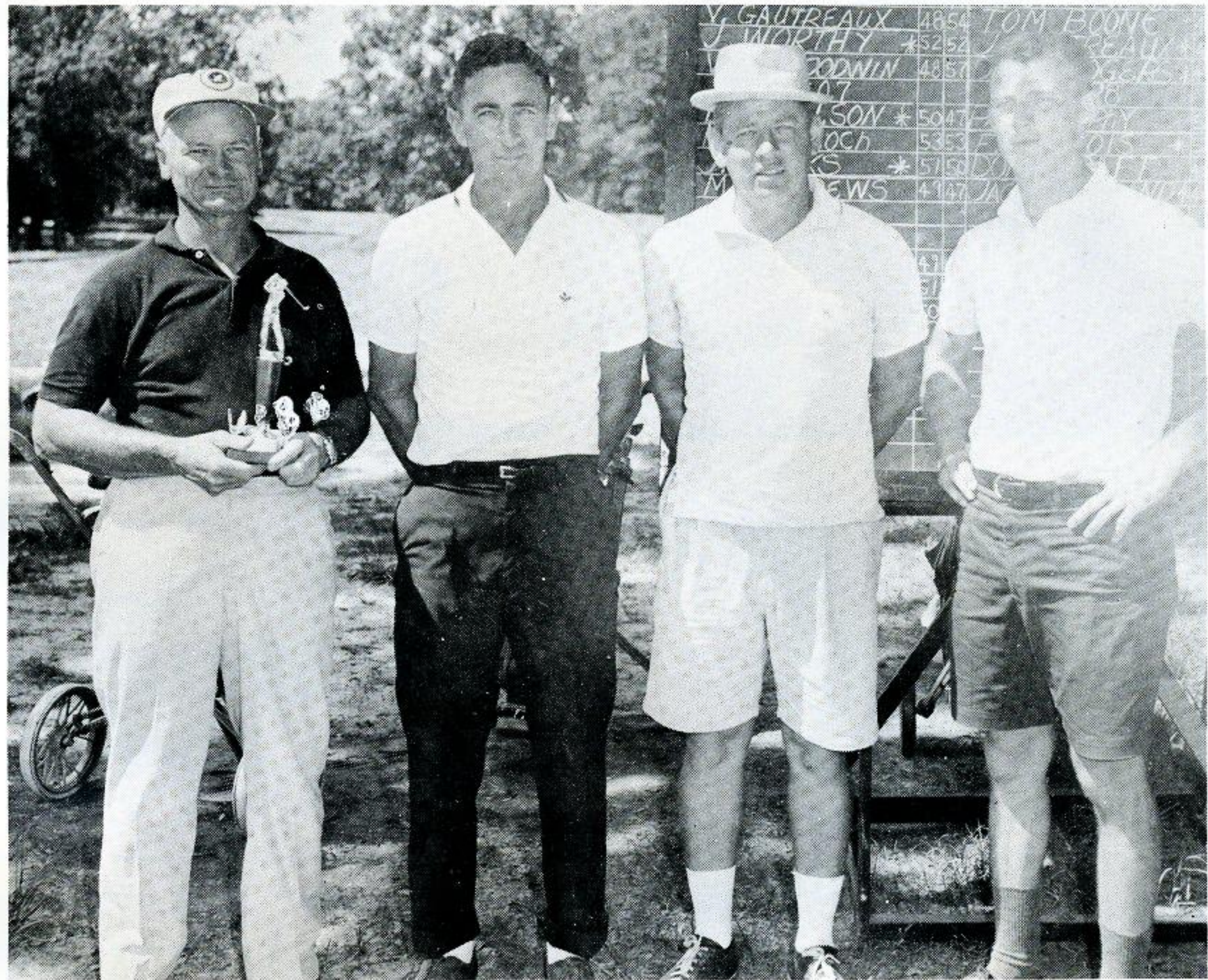

A blind nine handicap system was the order of the day at Baton Rouge, where 38 employees toured the tight, wooded Webb Memorial Golf Course.

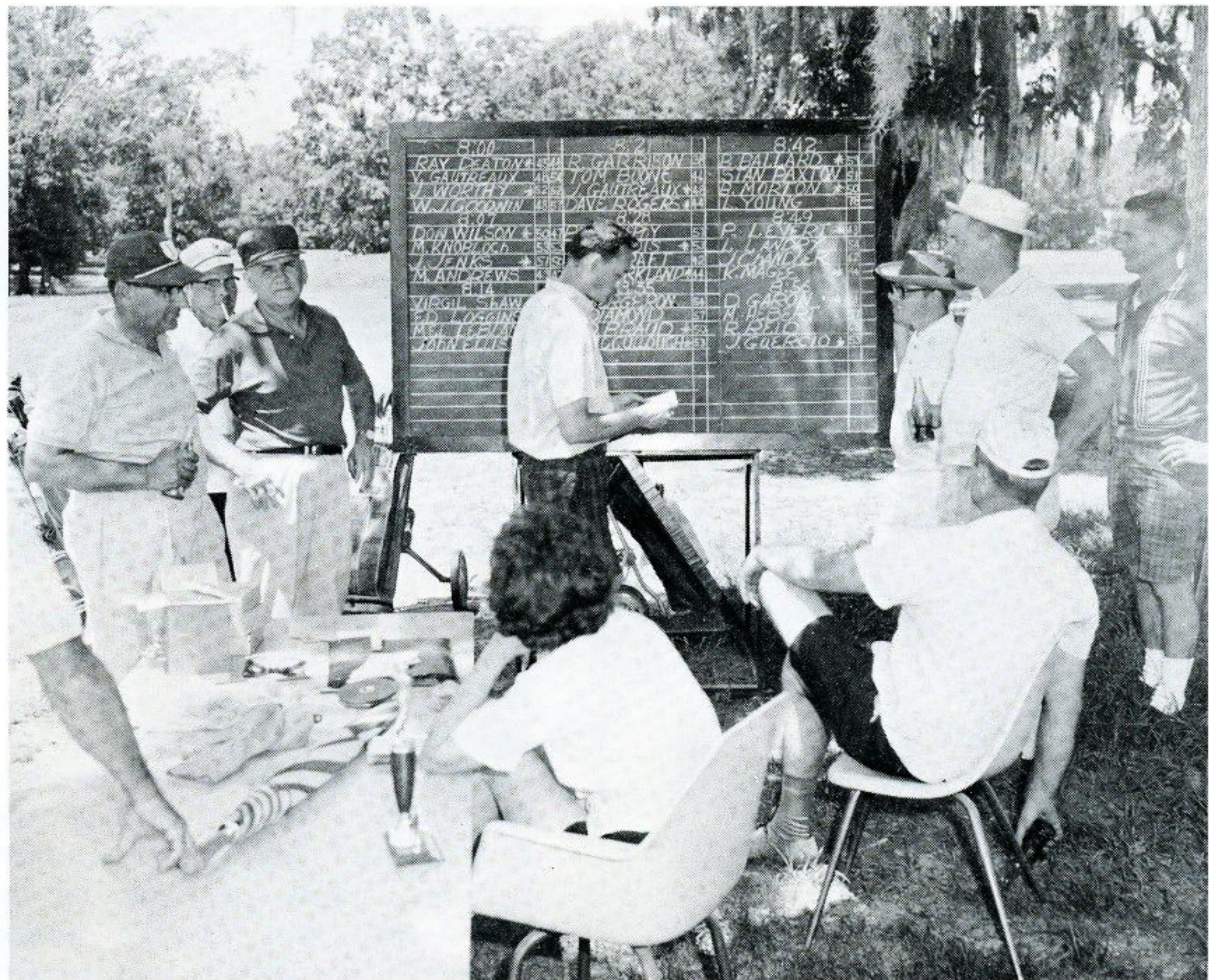

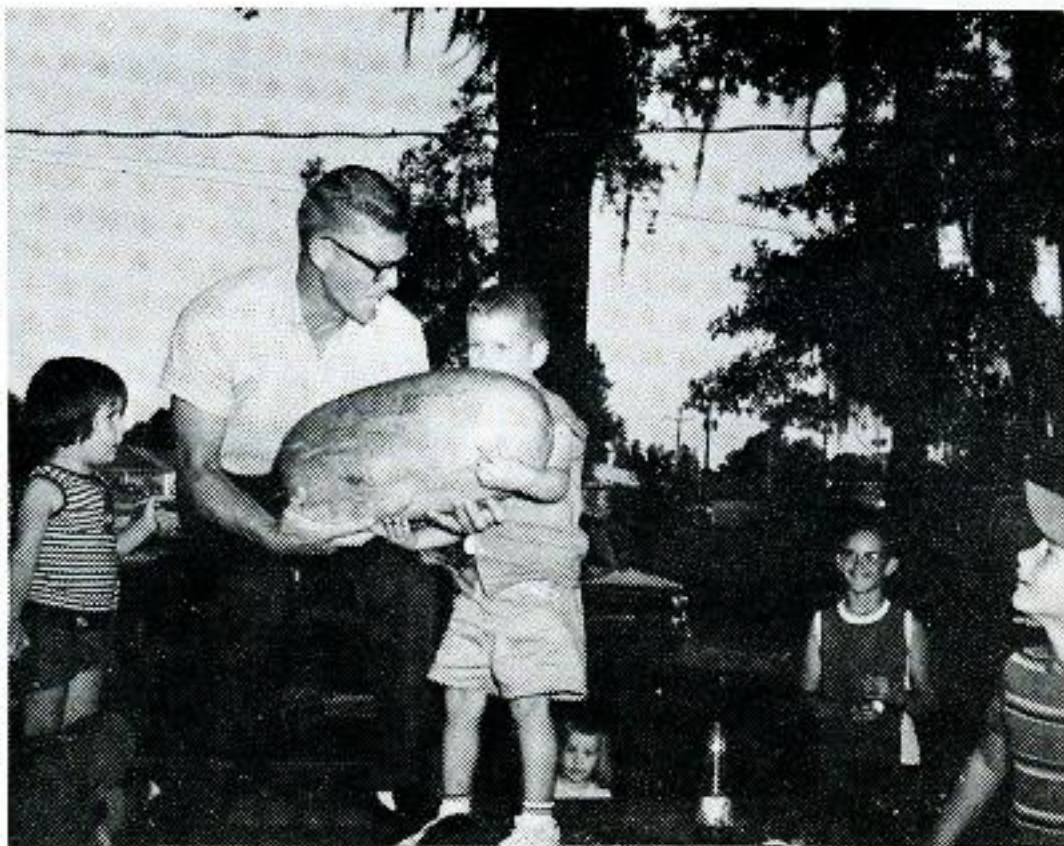
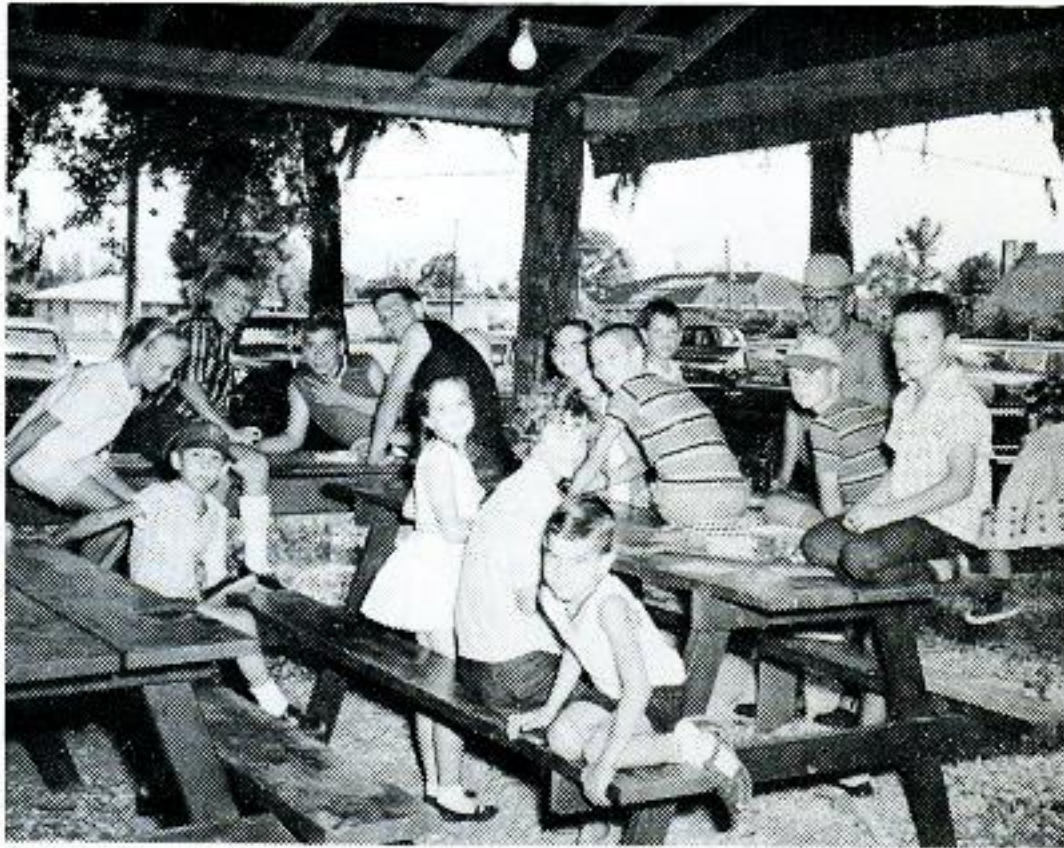

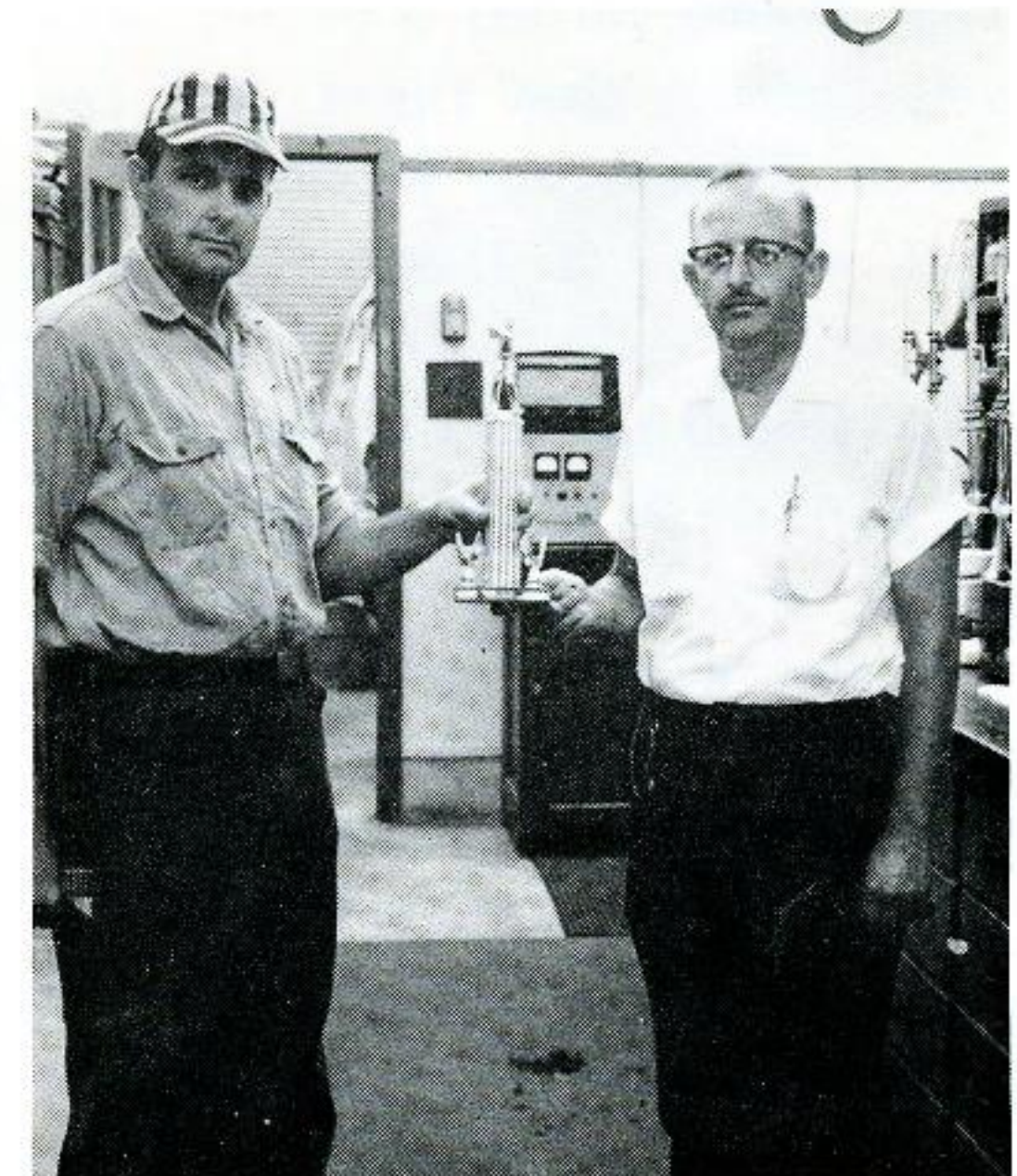

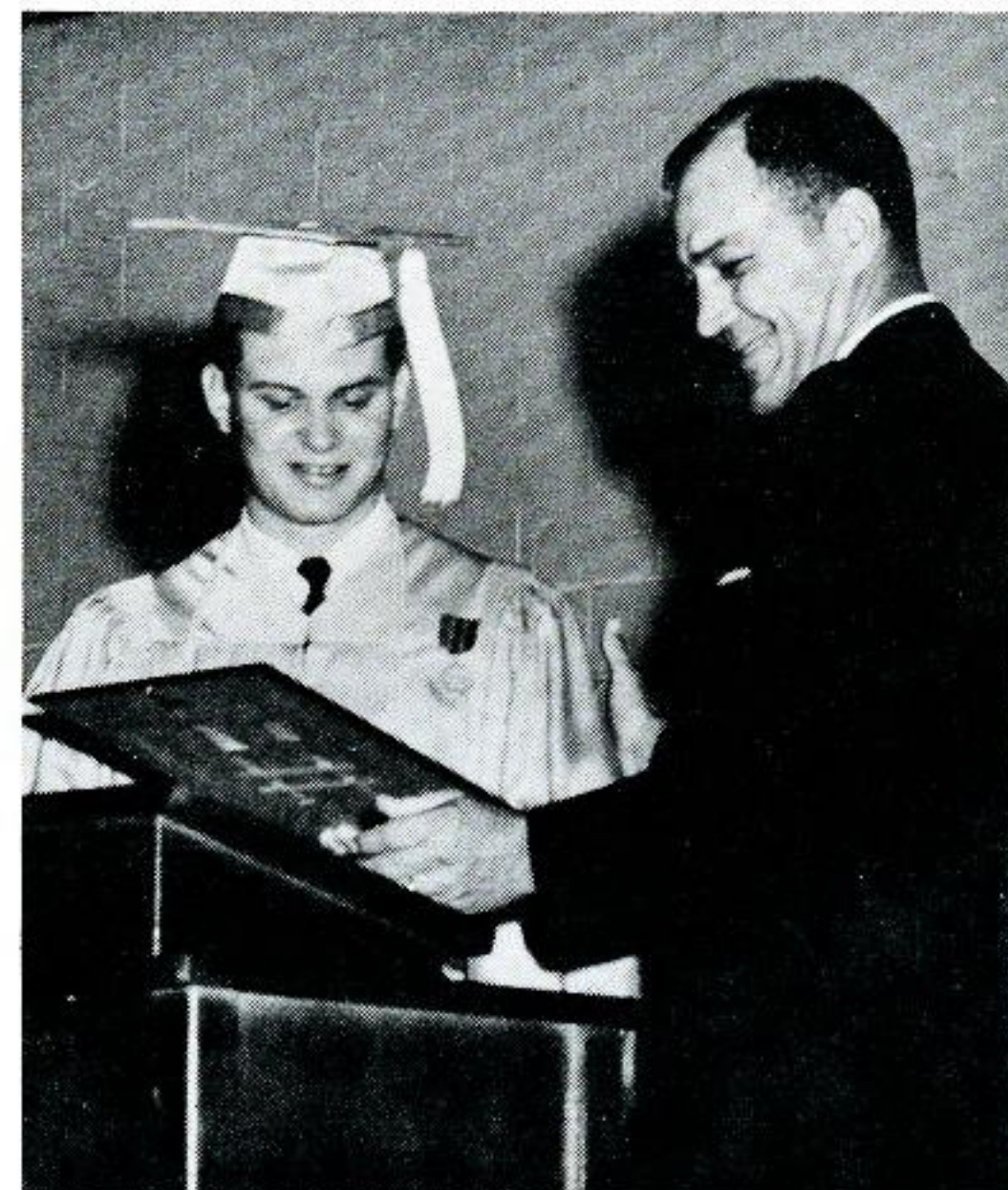

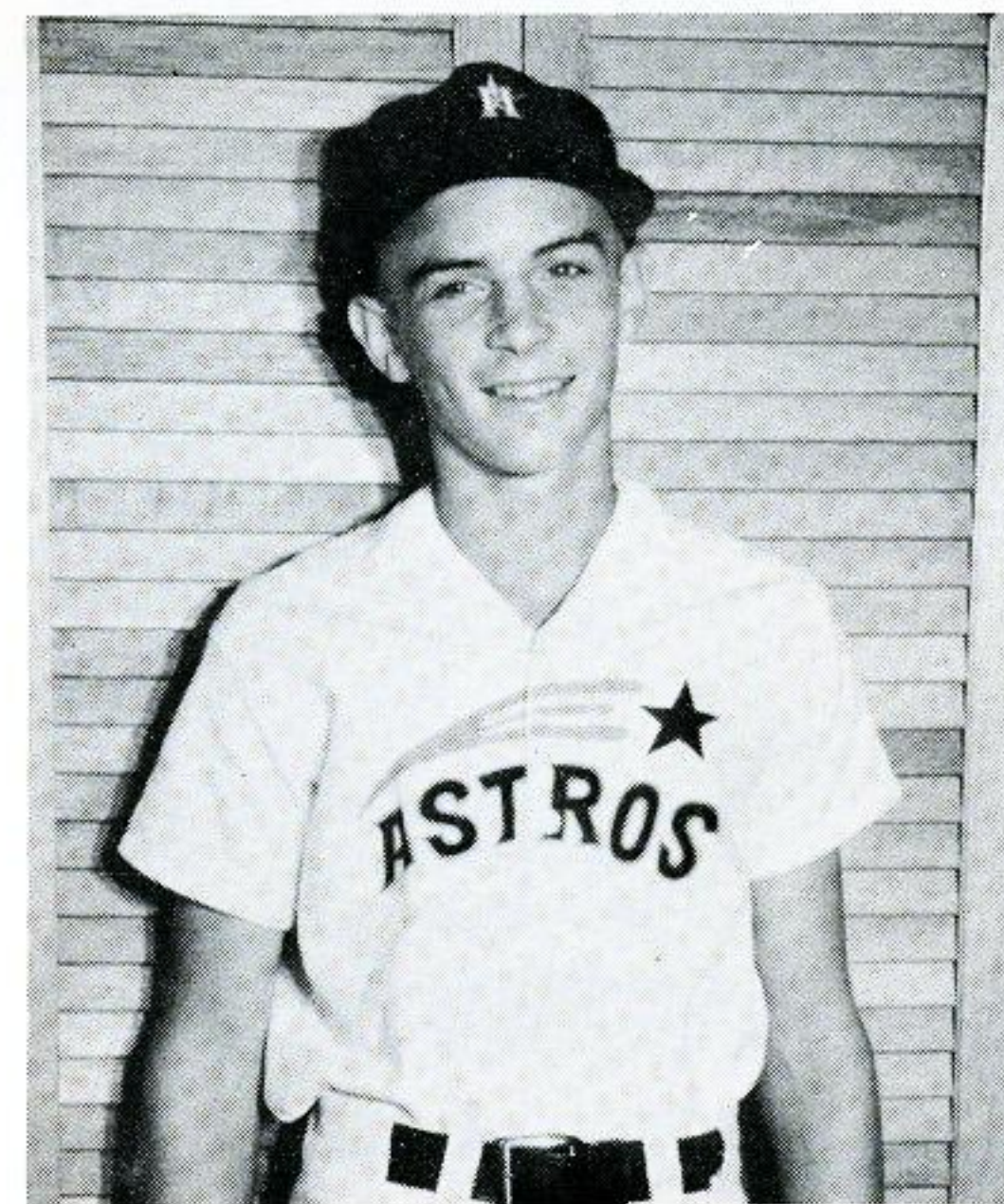
