

River Bend's emergency plan to aid communities lacking disaster plans

With River Bend Station less than a year from completion, company officials are putting the final touches on the emergency

plan for the nuclear-powered generating plant.

While it is highly unlikely the plan will ever actually be needed, Gulf States wants to develop the "very best emergency plan possible," emphasizes Jim Booker, manager-engineering,


nuclear fuels and licensing.

The most important part of the emergency plan deals with a 10-mile radius of River Bend — the part that falls within the NRC's "Plume Exposure Pathway Emergency Planning Zone". Within that zone lie parts of West Feliciana, East Feliciana, East Baton Rouge, West Baton Rouge and Pointe Coupee parishes, as well as 22,500 residents and 13,500 transients.

John Cadwallader, River Bend's supervisor-emergency planning, echoes Booker's judgment that the plan will probably never be utilized for a nuclear emergency, especially so far as an evacuation is concerned. Nevertheless, warning systems, communications systems and back-ups to each must be established within the 10-mile radius. Since four of the five parishes are largely rural, in most cases GSU is providing the area's only emergency planning system. Because of that, company officials are attempting to ensure that the GSU system can also be used for natural disasters and other non-River Bend-related emergencies that might affect those areas.

Emergency planning is a complex process involving agreement among federal, state and local government agencies regarding the River Bend plan. Cadwallader says he believes the key to a successful emergency planning effort for a nuclear plant is to ensure that information is transmitted from those who have it to those who need it. That concept evolved from the lessons learned from 1979's Three Mile Island incident.

There are four classifications of emergencies for a nuclear plant. The first — notification of an

unusual event — could be something as simple as a wastebasket fire, Cadwallader explains. The succeeding classes of emergencies are an alert, a site-area emergency and a general emergency.

The first two classes are designed to provide early and prompt notification to off-site authorities of minor events which might lead to more serious consequences. The other two classes, site-area and general emergency, reflect conditions where some releases are possible.

Trained, capable people, both on- and off-site, will make the whole set-up work. Training of about 1,200 non-GSUs from various government, rescue and civil defense agencies will begin in August. Meanwhile, GSU personnel are now undergoing training.

On July 16, Region IV of the Nuclear Regulatory Commission (NRC) began a pre-operation inspection, which includes reviewing schedules and checking

how GSU employees are trained for an emergency. River Bend is only the second plant to come under the pre-operation inspection requirement, which is another regulatory response to Three Mile Island. The inspectors will return on a monthly basis.

All of the planning, training and equipping will culminate Jan. 16, 1985, in a full-scale drill involving on-site and off-site emergency preparedness personnel, medical personnel, transportation providers and the media. The timing is important, insists Cadwallader, since fuel loading for River Bend is scheduled for April 1985.

The January drill will help test the skills and equipment needed for a real emergency. Months before that takes place, however, GSU expects to pass another milestone. That will be receiving comments from the Federal Emergency Management Agency (FEMA) for the River Bend site-specific attachment to the State

of Louisiana Peacetime Radiological Response Plan.

GSU's emergency planning efforts are enhanced by the contributions made by Gen. Robert H. Barrow, who is a consultant to the company on the off-site emergency plan and the security programs at the plant. Gen. Barrow's experience in the management of large numbers of people under changing and unpredictable circumstances is directly applicable to emergency planning. He retired in 1983 as commandant of the U.S. Marine Corps, ending a 41-year career with the Marines. Gen. Barrow is also a member of the GSU board of directors.

Although no one in the company expects to need River Bend's emergency plan, the emergency planning effort will pay off for the surrounding communities, which can utilize aspects of the plan for other emergencies.

Company, union sign new two-year contract

At approximately 2 p.m., Saturday, June 30, a new two-year labor agreement was signed between Gulf States Utilities and the International Brotherhood of Electrical Workers (I.B.E.W.) Local 2286.

The agreement culminated negotiations between the company and union negotiating committees, which began on April 23. Tentative agreement on the new contract was reached the evening of June 23, with the union negotiating committee agreeing to a full committee recommendation. The agreement was ratified by union membership in meetings held throughout the GSU service area during the week of June 25.

Major contract changes include:
Wages

- A 4-percent increase for each year of the contract.

Life Insurance

- The first \$20,000 of life insurance coverage paid by the company. Previously the company paid the first \$10,000.
- Life insurance of two times an employee's annual base wage up to \$100,000. The previous cap was \$50,000.

Vacations

- Three weeks after seven years instead of three weeks after eight years.
- Four weeks after 16 years instead of four weeks after 17 years.
- Five weeks after 25 years instead of five weeks after 26 years.

Per Diem

- Effective June 24, 1984, changed from \$34/day to \$38/day.
- Effective June 23, 1985,

changed from \$38/day to \$40/day.

Additional changes involve shift differential, tool allowance, job titles, computer operator progression, district sub-station operator wage rate adjustment, River Bend master rates, regular shifts for some job classifications at River Bend, clarification of existing language and others.

The company negotiating committee was comprised of Allan Baker-chairman, Jim Braswell, George Cannon, Jim Deddens, Rose Grisham, Calvin Jaetzold, Bobby Joe Willis and Delbert Zimmerly. Those on the union negotiating committee were George Crawford-chairman, Dale Arbour, Kathy Bourgeois, Michael Cormier, Deryl Hart, James Ochoa, Terry Ross, Kenny Shaver and Nancy Thibodaux.

Nelson Gas & Oil

Maintenance gets priority

While Nelson Gas & Oil and Nelson Coal are quite different operations, they share a common distinction. They are the only plants in the Gulf States system located adjacent to each other. Nelson Gas & Oil is the senior of the two, feeding electricity to customers since 1959.


Plant superintendent Clifford Chambers was promoted from operations supervisor last January and is a 42-year veteran with GSU. Chambers puts a high priority on maintenance. "We're not running all five units simultaneously," he says, "but we must keep them available to operate at peak efficiency when they are needed." Since only two units are currently needed, the units are operated in rotation to keep them in top working order. "Boilers and boiler parts get constant attention so they will not deteriorate. It is a bigger challenge to keep units in good condition when not running than it is to run them full time," says Chambers. Equipment left idle can corrode unless it is properly maintained. In the future, the plant may turn to cycling — reducing the load at night when it is not needed and increasing it in the daytime to meet the need. When the Exxon natural gas contract expires, Chambers

expects a greater demand on his plant. "Fuel costs in Louisiana are higher than in Texas. We're buying gas on the spot market at current prices. When the Exxon contract is over, our fuel costs will be similar to those in Texas," he says.


Chambers compliments his employees for keeping Nelson Gas & Oil a clean, well-kept place to work and is very proud of the plant safety record. "We won the President's Safety Award in 1981 and 1982," he points out, "and are working to win it again this year."

Employees earn safety awards

Employees at three GSU power plants and two divisions have been cited by the Edison Electric Institute for their outstanding safety records.


Employees at Neches, Sabine and Willow Glen stations and the Baton Rouge and Lake Charles divisions received the EEI safety achievement awards, reports Mike Durham, manager-occupational health and safety.

The awards recognize employees at those work locations which attain 1 million or more safe man-hours. "These employees have worked at least that long without suffering any work-related injury or illness that resulted in one or more days away from work," explains Durham. According to Durham,

at press time, the power plants were continuing their records.

At Neches Station, an average of 114 employees were recognized for having earned 1,061,568 safe work-hours from May 17, 1979, to Jan. 31, 1984. An average of 222 Sabine Station employees attained 1 million safe work-hours from Dec. 27, 1981, to Jan. 3, 1984. Willow Glen Station employees (an average of 226) earned 1,015,870 safe work-hours from Oct. 26, 1981, to Jan. 31, 1984.

In the Baton Rouge Division, an average of 826 employees worked 1,552,155 safe work-hours from Aug. 6, 1982, to July 25, 1983. An average of 467 employees in the Lake Charles Division logged 1,061,491 safe work-hours from Nov. 11, 1982, to Dec. 27, 1983.







at maneuvering the small crafts. "The trick," he reveals, "is to sit in the middle of the boat when you get into a big waterfall. That way, you lower the center of gravity."







Harley Erickson surveys the water from his sailboat.





The proud grandfather, who has been with GSU 35 years, is a unit supervisor at Willow Glen Station.


Parents of the little boy are Ronnie and Tara Reid McAllen, also of Baton Rouge.

Baby Angela joins Eaglins



The little dancers were featured in numbers reflecting the theme of the 1984 World's Fair in New Orleans.








McKenzie earns speaking award

Sorrell relates success to childhood traits

From early childhood on, Sheila Sorrell felt that she "always had to be a leader."

During her school years, she satisfied that yearning by serving as a home room officer. At Gulf States, she has been a union steward and held leadership positions with United Givers, Project CARE and the Adopt-a-School program.

Sorrell, 33, mentions one other personality trait that surfaced in early childhood. "I enjoy being part of a team," she says, attributing that attitude to having been "the youngest of two children."

That means she enjoys her job as a section head in Customer Accounting, where she supervises 23 employees. She says she believes that she would hate working as "a 'Girl Friday' anywhere."

Sorrell's first job was with a Baton Rouge department store, where she modeled and managed the junior sportswear department.

Eight years ago she came to GSU, working as a customer accounting clerk, relief clerk and PBX operator. Knowing first-hand how important employee input is to work methods, Sorrell attempts to give those who report to her "the opportunity to be people." She does so by encouraging them to "speak up" during weekly 30-minute training sessions to help the whole group do a better job.

During Sorrell's first few

months as a supervisor, she could not separate her work and home lives. Eventually, she realized that "I had to."

As the divorced mother of a teen-aged daughter and a 9-year-old son, Sorrell devotes her weekends "to running here and there with them." Now an active member of Parents Without Partners, she strives to "let the other members know that

being single is not the worst thing in the world."

On weekday evenings, Sorrell works out at her health club, finding that the best way to relieve tension.

The energetic woman is also pursuing a degree in public relations at Southern University.

Sorrell probably owes much of her success to her ability to fully commit herself to the activities she enjoys. For instance, she has temporarily suspended her participation in Toastmasters. "I'm pretty busy now. When I commit myself to anything, I like to be totally committed," she asserts.
