# Gas service poses unique challenges

Most of GSU's 500,000 customers know Gulf States as an electric utility, but to over 86,000 customers in the Baton Rouge area, the company supplies natural gas. The Gas Department, organized in 1859 as an independent company, is the oldest of all the predecessors of GSU.

"Our people have the goal of providing the best possible service to our customers," says Floyd Marston, operating superintendent. His 107 employees are responsible for over 1,350 miles of gas mains. It is in the area of customer service that gas department operations differ significantly from electric service operations. "For instance," says Marston, "gas customers can't simply be turned off and on like electric customers. And there's no such thing as load-shedding." Load-shedding is cutting off electricity to compensate for the loss of a transmission line or a

generator. Each residential or commercial gas meter must be turned on individually, and each gas appliance must be turned on one at a time, with the customer there to let the serviceman in. The last major gas outage Marston recalls occurred in 1956 when the supplier lost a line. It happened, ironically, on a cold January morning on Friday the 13th.

It is because of these turn-on and turn-off procedures, and stringent state and federal regulations protecting the public, that gas service employees have much face-to-face contact with customers.

The bone-chilling cold which blanketed the GSU service area in late December put as much of a demand on gas operations as it did on electric service. It caused residential use, which constitutes the bulk of gas service customers, to rise dramatically. "We had to make sure there was an adequate supply of natural gas to




Larry Williams, apprentice, checks out the location of a possible natural gas leak.

all of our customers," notes Marston. The system was closely monitored.

Gulf States buys most of the natural gas from a supplier near Baton Rouge. GSU is always looking for new gas supplies to bring down the cost to customers. "Eight-five percent of our total operating expense goes for the cost of gas," says Marston, "so inexpensive natural gas is very important."

Last October the gas department started an additional money-saving program which is having significant results. Some 75 percent of the cars and trucks used in daily operations now run on either compressed natural gas or gasoline. A switch inside each vehicle allows the driver to operate the engine on either fuel. "We are saving about 40 cents per gallon on gasoline by using compressed natural gas," says Tom McBryde, operating supervisor. "There is a 10 percent loss of power so the engines are a bit sluggish," he points out, "but there are many advantages." Besides saving on the cost of gasoline, McBryde emphasizes that pollution is greatly reduced, engine life is extended, mufflers last longer and fewer oil changes are necessary. Eventually, all gas department vehicles will be converted to run on either fuel.

# GSU holding its own, Murrill tells shareholders

The message that Board Chairman Paul Murrill delivered to the 59th annual shareholders meeting was that GSU continues to hold its own, despite difficult regulatory and economic developments.

During the May 3 session in Edison Plaza, Dr. Murrill described 1983 as a year in which financial performance was good. "Earnings per share were \$2.31 versus \$1.95 in '82, when there were 17 percent fewer shares outstanding," he pointed out. He attributed the increased earnings to rate relief granted late in 1982.

Murrill added, "There's a general strength in the level of (industrial) activity and the level of capacity utilization." He explained that the upturn is mostly due to the U.S. economic recovery.

In answer to a shareholder's question, Murrill indicated that he expects the company's "underlying financial health" to make "a dramatic improvement" once River Bend 1 is on line and in the rate base.

The annual meeting signaled the retirement of board member Dr. Lorene L. Rogers and the election of Gen. Robert H. Barrow as a board member. It also marked the 25th year of board service for Edwin Hiam, an investment adviser from Boston, Mass.

Murrill announced Dr. Rogers' retirement with the comment that, "No one can replace her."

He added, however, that he feels "she is being followed by an individual who is well-qualified to help us meet the challenges of the next few years."

Dr. Rogers, president emeritus of the University of Texas, retired from the GSU board after eight years as a director. Gen. Barrow, who retired as commandant of the Marine Corps last July, has also been retained as a consultant to the company on the off-site emergency plan and the security programs at the River Bend plant. He is a native of West Feliciana Parish, where River Bend is located, and returned there to reside after retiring.


Among Barrow's latest achievements is his January appointment to the Foreign Intelligence Advisory Board by President Reagan.

Stockholders also re-elected the 12 incumbent members of the board.

Other comments made by Murrill included:

— "Certainly, the biggest construction project underway — which represents fuel diversification in a dramatic way — is River Bend..." Calling the 68-month construction schedule "very aggressive," he reasserted that the schedule has not changed.

— "Exxon never flinched from the contract (to provide low-cost natural gas for a 20-year period), but they've enjoyed all of it they want to have."

# Sees 'continuous thread' at GSU

Times have changed, but James H. "Jim" Derr sees "a continuous thread" running through the GSU he has known for the past 44 years.

"Back in 1940, the idea was to provide service at the lowest price with reliability. It's the same today," says Derr, vice president-power plant engineering and design, who retires June 1.

"Even though we're a regulated industry," continues Derr, "I can think of many GSUers who worked long hours because they felt an obligation as individual employees. They were motivated by a desire for excellence."

Of course, times have changed the company, Derr admits.

"One evident change is that GSU is much larger now than it was when I first came in 1940," recalls the Tremont, Pa., native. Further, the company is affected "by so many external factors now."

Derr's career began in 1940 at Louisiana Station following his graduation from the Williamson Trade School in Media, Pa., where he studied power plant operations. He was in the service from November 1941 until January 1943, when he resumed his GSU career.

Over the years, he worked at four power plants — Louisiana, Sabine, Riverside and Nelson — in such posts as test engineer, assistant to the plant superintendent, test supervisor and maintenance supervisor. He also held posts at GSU headquarters, including construction engineer and superintendent of plant construction.

Derr offers a little advice for ambitious new employees. "Become as familiar as possible — and dedicated — to your area, but broaden your interests to

become knowledgeable about other facets of the company."

Derr adds, "I feel strongly that no matter what job you have, you should never lose consideration for fellow employees. To a reasonable degree, consider their individual wants and desires. In return, people will produce and be very good employees."

Shortly after June 1, Derr plans "to get some kind of part-time job. I want a minimum of employment, but nothing that's too restrictive." Because he and his wife, Joyce, plan to travel — perhaps to Germany and England — he hopes "to be able to pick up and leave whenever I'm ready."

Derr's job hunt stems from his belief that, "To have a successful retirement, you have to have some sort of goal."

Once he's gone from Edison Plaza, Derr will save memories of those who helped make his years at GSU good ones. They include F.A. Wilson, who was his first boss in 1940 and then supervised him again in Beaumont in 1965; the late W.B. Gurney, who worked with him at the various plants; and the late L.R. Eddins, a superintendent at Riverside.

From his days at Nelson Station, Derr remembers Cedric

Watler, Jim Meitzen, Bob Guidry, John Graves and a host of others as "a group of people who were dedicated during the start-up" of the plant.

The years at GSU were not without a little romance. After all, Derr met his wife through the maneuverings of a Louisiana Station friend, Cyril Dominguez. Joyce, a Memphis, Tenn., native whose stepfather also worked at the plant, agreed to Dominguez's request that she accompany Derr to a dance. The couple hit it off, and their marriage has endured 40 years. About three years ago, Mrs. Derr audited some courses at Lamar University, including one that focused on marriage. Not surprisingly, she was the longest-wed student in the class. Derr chuckles when he recalls that one young man looked at his wife in disbelief and asked, "How can you live with the same man for so long?"

In addition to overseas travel, the Derrs plan to visit family members, including two sons and one granddaughter in San Antonio and one son and one granddaughter in Bay City.

Derr's mother, now 86, and five of his brothers and sisters, all of whom still live in Pennsylvania, will hold a family get-together in that state July 8.

# GSU walks for the March of Dimes

No company-wide pledge total was available since Lake Charles Division scheduled its walk May 12, after presstime:



Gillespie said the measure would save time, money and materials, eliminate waste and help to assure the safety of GSU employees and the public.


## Dreher designates salary increase to scholarship

# Bubble Boy parents say thanks

David, the 12-year-old known to millions of Americans as "Houston's Bubble Boy," died last February after losing his life-long struggle with a rare disease which left his body without an immune system.

David's family, whose anonymity is still being protected, are residents of south Montgomery County and are Gulf States customers. Because of David's very special medical needs, GSU placed the family on a list of critical customers to be notified in the event of a prolonged power outage. This is standard procedure for anyone on life-sustaining equipment, and gives them time to locate emergency medical aid. If necessary, the company can on occasion make portable generators available during planned outages.

In March, David's family wrote an open letter of thanks to the thousands of people who gave their love to David. Excerpts of that letter are reprinted here with permission of Tom Bacon, editor of *The Courier* (Montgomery County, Texas):



## Space shuttle over Louisiana Station
